President George Otstott called the meeting to order at 10:00 a.m. Jack Salmon gave the invocation. Mr. Otstott led the directors in the pledge of allegiance to the United States flag.

On a motion by Robyn Shelton and a second by Jack Salmon, minutes for the October 23, 2023, meeting were approved. Motion carried, all voting aye.

Robyn Shelton made a motion to approve the monthly investment report, to approve financial reports on all current accounts and funds, and pay invoices for professional services. Stan Wyatt seconded the motion. Motion carried, all voting aye.

Osiris Brantley updated the Board on the remaining progress of tasks being performed by the rate consultant. NewGen Strategies, in conjunction with NETMWD, are continuing the development of a full forecasting model, and plan on drafting financial policies that will aid in developing reserves to be able to finance future capital improvement needs.

On a motion by Jimmy Cox and a second by Stan Wyatt, the bid for the restoration of the Hughes Springs ground storage tank was awarded to J&A Coating Company at \$183,942.00. Motion carried, all voting aye.

Patrick Smith made a motion to award the contract for the removal of sediment from Lake O' the Pines intake structure to Consor Engineering LLC at \$510.00/hour, \$9,00.00/day with 5 divers and a 4" hose. Stan Wyatt seconded the motion, motion carried all voting aye.

President George Otstott announced at 11:08 A.M. that the Board was recessing into a closed executive session for consultation concerning attorney-client matters with the District's legal counsel under Section 551.071, Texas Government Code, regarding items on today's Board meeting agenda; that no final action would be taken in closed session; and that, at the conclusion of the closed session, the Board will reconvene in open session with the public.
